This is to bring to your kind notice that we had, vide our letter dated 24<sup>th</sup> October, 2014, informed you about the devastating fire which took place in our Flexible Packaging Unit at Dankuni, West Bengal. The fire, which was of abnormal magnitude, completely gutted the unit.

We have been interacting with Universal Sompco General Insurance Company Limited, our insurer, for insurance claim. But, unfortunately, the insurance claim amount is not yet settled. The cost of Plant and Machineries including office building and electrical equipments is about Rs. 150 Crores.


We would like to put on record that the financial results of the company for the year ended 31<sup>st</sup> March, 2015 will be adversely and negatively impacted. The quantum of loss is dependent on insurance claim to be settled. Because of this reason, we have been unable to finalise the accounts for the year ended 31<sup>st</sup> March, 2015 and get the same audited. It appears that it will take some two months more for us to get the exercise completed. As such, we will not be able to furnish you the audited financial results for the year ended 31<sup>st</sup> March, 2015, by 30<sup>th</sup> May, 2015, as required by clause 41 of the Listing Agreement. However, we are confident to furnish you the Audited results latest by 31<sup>st</sup> July, 2015.

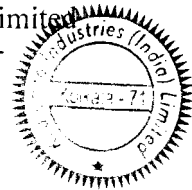
We sincerely hope that you will bear with us for the time being.
